What is this product?

Type

The product is a share class of the sub-fund Templeton Emerging Markets Sustainability Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek long-term investment growth, through growth of capital, while positively contributing to sustainable goals.

Investment Policy

The Fund mainly invests in equities of companies of any market capitalisation that are located in, or derive significant business from, emerging markets. These companies have positive environmental and social performance, improved ESG footprint and potential for improvement through stakeholder engagement.

These investments may include depositary receipts. To a lesser extent, the Fund may invest in convertible securities, depositary receipts, corporate and government bonds and in China A-Shares (notably through Shanghai-Hong Kong Stock Connect, Shenzhen-Hong Kong Stock Connect) and in China B-Shares.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth (in accordance with the risk profile of the Fund).

Strategy The investment manager uses an investment idea-generation process to select companies that meet the Fund's sustainability criteria and appear to offer above-average potential for appreciation over the long term.

Sustainable investing The investment manager applies a proprietary rating methodology using various ESG criteria in pursuing its sustainability objective. The Fund analyses the sustainability characteristics of company business models and invests in companies whose activities are aligned to an environmental or societal outcome, or that are improving their ESG footprint. The Fund also excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, gambling and weapons. The investment manager engages in dialogue with companies concerning ESG issues.

- are interested in a thematic exposure to emerging equity markets as part of a diversified portfolio
- have a high risk profile and can tolerate significant short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

Terms to understand

depositary receipts: Certificates of ownership that allow shares to trade in markets where they are not registered.

derivatives: Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

emerging markets: Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

equities: Securities that represent partial ownership of a company.

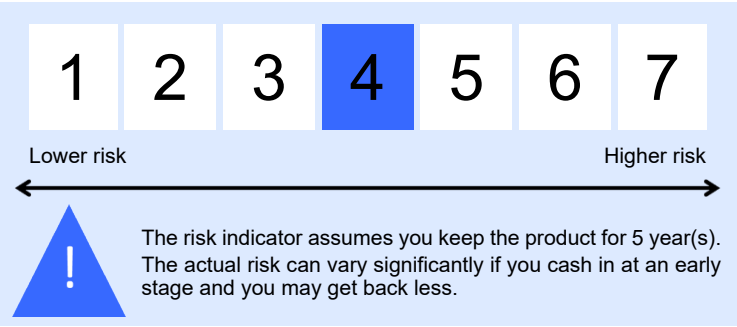

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- USD 10 000 is invested
